Guidelines for Submission

As part of the submission process, the author(s) are required to ensure their submission's compliance with the below stated, and the ones not in adherence with the same shall not be published.

- ♣ The submission has not been previously published by any other Journal.
- The author(s) shall compulsorily annex a document containing a declaration that shall clearly indicate that the submission is the original work, and shall also contain a plagiarism report. It shall also state that the views presented in the manuscript are entirely personal and the author(s) take full responsibility of any resultant error or loss to any property/person.
- ♣ The following details as per the order stated shall be provided in case the manuscript forwarded contains a Book review:
 - Name of the Author(s)
 - Title of Book Reviewed
 - Place of Publication/ Name of the Publisher
 - Year of Publication

- ♣ An Abstract of about 250-300 words shall be submitted along with the manuscript. The same shall be followed with at least 5 to 6 keywords.
- The following word limit shall be adhered to:
 - Research Papers and Articles: 4000-6000 words
 - Case Law and Book Reviews: 2000-3000 words
 - Legal Expressions/ Perceptions and Global Views/ Comments 1500-2500 words
- ♣ The main text shall be typed-1.5-line-spaced MS Word Document with Times New Roman marked at Font-12.
- Footnotes shall be the only mode used for citing. The Indian Law Institute's Citation Style shall be followed for the purpose. It shall be typed-single-spaced with Times New Roman marked at Font 10.
- ♣ The author(s) shall properly state the statistics to the table/ figure, in case the same is added to the text.

The manuscript shall be forwarded to the Board for the process. The recommendations, if any, will be duly send to the author(s) for corrections and further resubmissions.

Mere submission shall not claim for publication. The Editorial Board for the Journal reserves the right to edit and publish the contributions.

PUBLICATION AND ETHICS POLICY

The Ideal Journal of Legal Studies (IJLS) is a peer-reviewed law journal of School of Law of the Ideal Institute of Management and Technology. Published annually, it is an endeavor of the Institute to address contemporary issues in the field of law.

IJLS is committed to adopt the highest standards of ethics and take all possible measures against any publication malpractices. All the members of the Editorial Board ('Board'), Advisory Panel, Peer Reviewers ('Reviewers'), Authors and Contributors are subjected to this policy.

1. Publication Decisions

The Editorial Board of IJLS is responsible for deciding which of the manuscripts submitted to the Journal should be published. It abides by legal requirements as shall then be in force regarding defamation, copyright infringement and plagiarism. The editors shall confer with the Board and the Reviewers in making this decision.

2. Non-Discrimination

The manuscripts would be evaluated by the Board and the Reviewers for the content without regard to race, gender, sexual orientation, religious belief, ethnic origin, citizenship, and/or political philosophy of the Author(s).

3. Confidentiality

The Board and the Reviewers will not disclose any information about a submitted manuscript to anyone other than the corresponding Author(s), Reviewers and the Board.

4. Privacy

Unpublished materials disclosed in a submitted manuscript will not be used by any of the Board members or Reviewers in their own research without the express written permission of the Author(s).

5. Acknowledgement of Sources

The Author(s) should always duly acknowledge the work of others and should cite the influential publication. The Author(s) is directed to not use the information obtained by conversation, private correspondence or discussion with third parties without express permission from them.

6. Fundamental Errors in Published Works

If the Author(s) discovers a significant error or inaccuracy in their own published work, it is their obligation to promptly notify the Board and cooperate with to retract or correct the paper.

7. Conflict of Interest

The Board, the Reviewers and the Author(s) are to acknowledge upfront any relationship that they think could be said as resulting in a certain or perceived conflict of interest with regard to the manuscript. If an editor of the Board has a conflict of interest that may bias their treatment of the manuscript under consideration, they will excuse themselves from handling the same.

8. Plagiarism and Improper Authorship

Submissions will be subjected to a check for any plagiarism in the first stage of evaluation. Any cases of plagiarism or improper authorship on behalf of the Author(s) will not be tolerated and shall stand rejected in the first instance. Plagiarism can occur in respect to all types of sources and media. Improper authorship refers to cases where the person who has contributed the manuscript is unqualified as an author or where someone who has not contributed to the manuscript but has been listed as an author merely to express gratitude or any other reason.

9. Dealing with Unethical Behaviour

Unethical behaviour may be identified and brought to the attention of the Board at any time and by anyone. Whoever informs the Board of such conduct should provide sufficient information and evidence in order for an investigation to be initiated. All allegations will be taken seriously. The Board will contact the Author(s) of the manuscript and giving due consideration of the respective complaint or claims made, may also, reject the article or if published, issue a formal notice for formal retraction or withdrawal of publication from the journal.
