Criterion IV – Infrastructure and Learning Resources

4.1.1 The Institution has adequate facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc. (5)

The institute is located in an easily accessible area of East Delhi, well-connected by metro rail, enhancing its convenience. The spacious and thoughtfully designed campus building showcases modern architectural elements, providing a highly suitable environment for students.

- a. University norms related to infrastructure are duly fulfilled.
- b. Infrastructural norms laid down by the Bar Council of India are followed. However, in addition to these norms institute has other teaching learning resources available for the effective class room transaction.

The institute has the following infrastructural facilities:

1. **Class room:** There are 22 Class rooms in the institute with LAN and Wi-Fi Facility.
2. **ICT lab:** The computer lab is furnished with 83 computers, connected through both LAN and Wi-Fi networks, complemented by an LCD projector, a projection screen, CCTV cameras, and an array of essential software applications. Students can work individually, benefiting from amenities such as a microphone, a soundbar, computers, printers, scanners, and photocopiers. Additionally, the campus boasts widespread Wi-Fi accessibility, featuring a state-of-the-art IT infrastructure that encompasses cutting-edge computing and communication resources, thereby enriching the teaching and learning environment.
3. **Library:**
 - a. IIMT boasts two distinct libraries, one dedicated to law and another to management studies. The collection encompasses an impressive 24,706 books, including three rare editions: "The Constitution of India-1950," "Speeches of President Fakhruddin Ali Ahmed," and "Jawaharlal Nehru Speeches, Vol. 03, 1953-1957." Additionally, the institute subscribes to a notable selection of 41 national and international journals, while students gain access to around 250 online journals of both national and international repute through their DELNET membership. The library also offers a varied assortment of periodicals, featuring eight magazines and ten daily newspapers, contributing to the continuous enrichment of both faculty members' and students' knowledge. Furthermore, the institute's library network extends to include memberships with the British Council Library, DELNET facilities, Indianjournals.com, Publishingindia.com, and SCC (tailored particularly for law students), providing an extensive range of resources to foster comprehensive learning and research endeavors.

- b. Moot Court:** A The well-equipped Moot Court serves as a vital training ground for law students, aimed at elevating their professional capabilities and argumentative competence through simulated trials on legal matters. This platform offers a close-to-real experience of a courtroom setting, enabling students to engage in research, debates, and discussions surrounding hypothetical cases. This immersive environment significantly enhances their advocacy skills, fostering a holistic development of their legal expertise.

Conference hall and auditorium: The campus features a fully air-conditioned and extensively equipped conference hall boasting a Smart Board accompanied by a Projector, an advanced audio system, CCTV surveillance, and seating capabilities for over 60 individuals. The institute also houses two distinct Auditoriums: a mini auditorium and a main Auditorium. The mini auditorium stands as a well-furnished space incorporating an LCD projector, a smart board, CCTV monitoring, and an audio system, catering to an audience of 100 students. Conversely, the main auditorium sets itself apart with complete air-conditioning, sophisticated furnishings, and a comprehensive setup encompassing two LCD projectors alongside dual Projection screens, an advanced audio system, CCTV cameras, and microphones, accommodating a crowd of more than 400 students.

- c.** To cater to the requirements of differently abled students, the institute has both a ramp and an elevator in place.
- d.** The institute offers assistance and support to visually impaired and handicapped students during their end-term examinations.

Sports: In-charge oversees sports, guides students; marker readies field, supplies equipment; success with strong indoor/outdoor facilities.

Canteen: Within the vicinity, there is a conveniently located cafeteria. This cafeteria offers a range of dining options, making it easy for individuals to enjoy meals and refreshments. It serves as a welcoming space for students and staff to gather, socialize, and grab a bite to eat. With its proximity, it adds to the overall convenience and accessibility of the institution's facilities.

Staff Room: IIMT, the institution in question, boasts a total of three staff rooms within its premises. Among these, two are designated for the management department, providing a dedicated space for administrative tasks and discussions. Additionally, there is a separate staff room allocated exclusively for the law department, facilitating a conducive environment for legal professionals to collaborate and work efficiently. This arrangement ensures that both departments have access to their own dedicated spaces, promoting effective communication and productivity among the staff.

Infrastructure Facilities: The infrastructure of our institution boasts a range of well-equipped facilities that cater to the diverse needs of our students and staff. We have a total of 22 spacious classrooms that provide an ideal environment for learning. Additionally, we have a Moot Court, a Management Room, a Director's Room, and three Principal's Rooms, all contributing to the administrative and academic functions of the institution. The Vice Principal's office, IQAC Room, Administrative Office, Guard Room, Reading Rooms, Sports Room, Gymnasium, and Medical Room further enhance the overall infrastructure. For gatherings and events, we have a Conference Hall with a seating capacity of 60, a Main Auditorium accommodating 400, and a Mini Auditorium for 100 attendees. In addition to these, our institution houses a Legal Aid Cell, a fully equipped Kitchen, three Staffrooms, a Placement Cell, two Computer Labs, and two Libraries. To cater to the culinary needs of our students and staff, we have a Canteen, and for relaxation and socializing, we provide two Common Rooms - one for boys and one for girls. These facilities collectively create a conducive and enriching environment for both academic and extracurricular activities within our institution.

Utilities facility: Our institution boasts a wide array of utilities that enhance the overall experience and safety of our campus. We are equipped with two elevators (lifts) to facilitate easy movement across floors, complemented by two ramps designed for accessibility, ensuring that everyone, including individuals with disabilities, can navigate the campus comfortably. In terms of hydration, we offer seven water coolers, with six strategically placed on each floor and an additional one located outside the college for the convenience of both students and visitors.

To guarantee an uninterrupted power supply, our campus houses two generators. We prioritize safety with a comprehensive fire safety system that includes fire extinguishers, an automatic sprinkler system, and smoke detectors in the basement, along with fire doors, first aid hose reels, a downcomer system, house boxes equipped with hose pipes and branch pipes, and a dedicated pump room on the ground floor containing fire pumps and overhead fire pumps. In total, there are 40 fire safety devices distributed across the campus.

Security is paramount, and to ensure it, we have installed 52 CCTV cameras throughout the campus for monitoring and safety purposes. Additionally, our campus is equipped with 62 air conditioning units to provide comfort to all occupants.

Water storage is well-maintained with both underground and overhead water storage tanks, boasting capacities of 70,000 liters and 10,000 liters, respectively. Furthermore, we provide five microwaves, five fridges, and one Photostat machine to cater to various needs within the institution. These utilities collectively create a safe, comfortable, and well-equipped environment for our students and staff.
